THE ISSUE OF STRENGTHENING ANTI-GLOBALIST MOVEMENT WITHIN THE CURRENT WORLD ECONOMY

Abstract

This article is devoted to modern issues of strengthening anti-globalist movement within the globalization processes of the world economic space. There are many approaches to explaining the causes of emerging the anti-globalist movement. It was created to combat the effects and consequences of globalization. Others are associated with other social or political movements – pacifist, environmental, solidarity with 'Third World' countries or peoples, left radical, anarchist, communist, etc. Some activists reject the undemocratic and unfair mechanisms of the processes of globalization, and others – capitalism and freedom of trade and etc. However, they all agree on the neoliberal version of capitalism and international economic and financial institutions that are considered to be its bearers such as the World Bank, the International Monetary Fund, the World Trade Organization, and etc. The globalization of business always has both positive and negative sides in the context of international influence and impact. Many economists-researchers consider and compare the modern process of globalization with the once-historical process of colonization, finding similar features in both processes. Most antiglobalists consider that the 'discovery' of markets and the freedom of movement of capital are not accompanied by the same openness of borders and freedom of movement of refugees.

Globalization and the anti-globalist movement have become interesting since the end of the twentieth century. What globalization means and why it is so important, and in which situation an anti-globalist movement could happen. What is the purpose and outcome of globalization in the modern world? Such as flashpoint model to two anti-globalization protests in Canada to explain why a demonstration had turned violent. The comparative study of two cases of anti-globalization in Canada: one being post-Seattle, but pre-Genoa while another being post-Genoa [1].

The Seattle, Washington anti-globalization was happened in the fall of 1999, by a vast number of social movement organizations, the Seattle protest against World Trade Organization (WTO) process of economic policy formulation. Because they perceive that this economic policy formulation destroys the principles of democratic decision making. There are a various group of people join in the protesting such as labor organizations, environmentalists, pagan groups, Christians, socialist and communist class-based group, feminist and anarchists. By this protesting, the incident of violent

attack happened to attack the business target they think to be enemy, the nonviolent marchers were disrupted. The violent attack was generated by a group proclaim as "Black Anarchists". The anti-globalization campaign initiated a series of physical confrontations with police. Anti-globalization is not new and continuous. The protesting group was called "SMO", Social Movement Organizations. There is cooperation among similar SMOs and get stronger on promoting the common program for change. They share information, human, intelligence exchange, material resource in their network.

The anti-globalization movement was created specifically to combat the effects and consequences of globalization. Others are associated with other social or political movements – pacifist, environmental, solidarity with Third World countries or peoples, left radical, anarchist, communist, etc. Some activists reject the undemocratic and unfair mechanisms of the processes of globalization, others – capitalism and freedom of trade and etc. However, they all agree on the neoliberal version of capitalism and international economic and financial institutions that are considered to be its bearers such as the World Bank, the International Monetary Fund, the World Trade Organization and etc [2].

Immelt is the chairman and CEO of GE [3].

Globalization is the international integration and international development. For business purpose of seeking profit, globalization, definitely might create a loss of the job from one place to another as the competition is not limited to country, region, but worldwide. The freer flow of business trade without trade barrier or tariff will generate cross-border business transaction more convenient than ever. The anti-globalization then just afraid of the outcome and protect the weaker or prevent rich powerful people to dominate the market and enhance their power for their own benefit. It is easy to understand and make sense of such an idea to protest. Contrarily, the protesting of change and avoid competition may also mean you keep the weak stay weaker without improving and find development solution for themselves. Main four key area was marked in the report which are globe environmental degradation, cybersecurity breaches, economic strains and geopolitical tensions despite an improved economic backdrop.

Economic growth leads people to adapt to enormous change that leads the impact to the geopolitical tension of nation. Аңдатпа

Аннотация

Статья посвящена современным вопросам усиления антиглобалистского движения в рамках глобализационных процессов мирового экономического пространства. Существует много подходов к объяснению причин создания антиглобалистского движения. Среди них борьба с эффектами и последствиями глобализации, взаимосвязь с другими социальными или политическими движениями – пацифистскими, экологическими, солидарными со странами или народами «третьего мира», левыми радикальными, анархистскими, коммунистическими и т.д. Некоторые активисты отвергают недемократические и несправедливые механизмы процессов глобализации, другие – капитализм и свободу торговли как таковой и т.д. Однако все они сходятся на критике неолиберальной версии капитализма и международных экономических и финансовых институтов, таких, как Всемирный банк, Международный валютный фонд, Всемирная торговая организация и др. Глобализация бизнеса всегда имеет как положительные, так и отрицательные стороны в контексте международного влияния и воздействия. Многие экономисты-исследователи рассматривают и сопоставляют современный процесс глобализации с некогда историческим процессом колонизации, находя схожие черты в обоих процессах.
